ORDINANCE NO. 2015-02

ZONING ORDINANCE AMENDMENT FOR INSTITUTION, RECREATIONAL AND EDUCATIONAL USES

AN ORDINANCE OF THE MAYOR AND TOWN COUNCIL OF MOUNTAIN LAKE PARK AMENDING THE ZONING ORDINANCE TO RESCIND THE CURRENT INSTITUTION, RECREATIONAL AND EDUCATION USE PROVISIONS AND ADOPT NEW PROVISIONS IN THEIR STEAD.

WHEREAS, the Mayor and Town Council of Mountain Lake Park is authorized by the Maryland Local Government Annotated Code Title 5, Subtitle 2, or its successor, and by the Mountain Lake Park Town Charter to enact ordinances to protect the health, safety and welfare of residents of and visitors to Mountain Lake Park, and

WHEREAS, on December 5, 2013, the Mayor and Town Council of Mountain Lake Park adopted a zoning ordinance regulating institution, recreational and educational uses, and

WHEREAS, the Town finds that the current provisions of Section 405, Paragraph 20, of said ordinance do not permit institution, recreational and educational uses in suburban residential (SR) zone, and

WHEREAS Section 405, Paragraph of the December 5, 2013 Zoning Ordinance states:

TOWN OF MOUNTAIN LAKE PARK ZONING ORDINANCE CHECKLIST

1. 12/30/14 Review and recommendation by Mountain Lake Park's Planning Commission.
2. 1/8/15 Introduce proposed ordinance to governing body. (Constitutes first reading.)
3. 1/15, 1/22, 1/29 Publish public hearing date and time and a fair summary of proposed ordinance once each week for at least two successive weeks, with the first such publication of notice appearing at least 14 days prior to the hearing.
4. 2/5/15 Conduct public hearing, and second reading. (The date of the public hearing must be set at least 6 days, but not more than 60 days, after introduction.)
5. 2/5/15 Adoption of Ordinance.
6. 2/5/15 Zoning Ordinance, amendment, supplement, change, modification, or repeal shall not become effective until 10 days after a public hearing.
7. 3/17/15 Wait 40 days from adoption to allow time for petition to ordinance referendum.
8. 3/18/15 If no petition is received, promptly register the ordinance with the County Clerk of Courts.
