ORDINANCE NO. 2024-03

ZONING ORDINANCE AMENDMENT FOR TABLE OF USE

AN ORDINANCE OF THE MAYOR AND TOWN COUNCIL OF MOUNTAIN LAKE PARK AMENDING THE ZONING ORDINANCE TO RESCIND CERTAIN PROVISIONS OF THE CURRENT INSTUTION, RECREATIONAL, AND EDUCATIONAL USES PROVISION AND ADOPT AMENDED PROVISIONS IN THEIR STEAD.

WHEREAS, the Mayor and Town Council of Mountain Lake Park is authorized by the Maryland Local Government Annotated Code Title 5, Subtitle 2, or its successor, and by the Mountain Lake Park Town Charter to enact ordinances to protect the health, safety and welfare of residents of and visitors to Mountain Lake Park, and

WHEREAS, on September 5, 2024, the Mayor and Town Council of Mountain Lake Park adopted a zoning ordinance regulating accessory and miscellaneous uses, and

WHEREAS, the Mayor and Town Council of Mountain Lake Park has decided to modify Section 405 Table of Use Regulations - Intuition, Recreational, and Educational Uses, (17), amending the permit requirement as follows subject to certain standards, permitting in certain zoning classifications as listed below.

WHEREAS Section 405, Paragraph 17 of the September 5, 2024 Zoning Ordinance states:

MISCELLANEOUS AND ACCESSORY USES	PD	TR	SR	C	AR	R	SW
(17) Day nursery, nursery school or other agency giving day care to Children, provided that: a) The use shall be conducted in a building designed for day care occupancy, and b) Any outdoor play area shall be sufficiently screened and sound insulated so as to protect the neighborhood from noise and other disturbance. To fulfill this requirement, screening must be located in an area approved by the Zoning Administrator.	N	N	N	SE	SE	P	N

BE IT ORDAINED AND RESOLVED, Section 405, Paragraph 17 of the Zoning Ordinance is rescinded and replaced by the following:


