Sewerage Processing Rates

THIS IS A RESOLUTION of the Mayor and Town Council of Mountain Lake Park to charge for sewerage processing and sewer maintenance charges.

NOW, THEREFORE, BE IT RESOLVED, this 2nd day of June, 2016, by the Mayor and Town Council of Mountain Lake Park, that all previous resolutions and ordinances pertaining to sewer usage fees, processing, or maintenance charges are repealed and the following charges are established for sewerage processing and maintenance charges:

WHEREAS, the Town of Mountain Lake Park Charter provides for the levying and collection of service charges for the use and maintenance of the sewer system; and

WHEREAS, the Town of Mountain Lake Park is empowered to bill and collect a service charge for the operation and maintenance of its sewer system pursuant to Section 26-31 (6) of the Municipal Charter of the Mayor and Town Council of Mountain Lake Park (as published in Municipal Charters of Maryland, Volume 4, 1990 Edition and November 2005 Supplement, and as from time to time amended)

NOW, THEREFORE, BE IT RESOLVED, this 2nd day of June, 2016, by the Mayor and Town Council of Mountain Lake Park, that the following fees for sewerage processing and maintenance within and without the town shall become applicable and shall go into effect for billing on or after July 1, 2015:

- (a) The quarterly minimum fee to be charged by the Mayor and Town Council of Mountain Lake Park for sewer use customers shall be \$41.71 per quarter for up to 4,000 gallons of metered water. All usage greater than 4,000 gallons in a single quarter shall be billed at the rate of \$6.52 per 1,000 gallons of metered water. All un-metered customers shall pay a flat rate of \$79.59 per quarter.
- (b) Where the Mayor or his or her authorized representative finds that a sewer user has a defective sewer service line or where evidence exists that a sewer user is discharging stormwater into the sewer collection system, the rates listed above shall be doubled until the problem is corrected by the property owner to the satisfaction of the Mayor or his or her authorized representative.
