**RESOLUTION NO. 2010-02**

**MUNICIPAL INFRACTION FINES**

**THIS IS A RESOLUTION** of the Mayor and Town Council of Mountain Lake Park to set fines for municipal infractions.

**NOW, THEREFORE, BE IT RESOLVED**, this 1st day of April, 2010, by the Mayor and Town Council of Mountain Lake Park, that all previous resolutions and ordinances setting the amounts of municipal infraction fines are repealed and the following fines are established for municipal infraction violations:

**Fines for Violations of Any Town Ordinance:**

First offense: Fifty dollars (\$50.00)

Second offense: Two hundred fifty dollars (\$250.00)

Third and all subsequent offenses: Five hundred dollars (\$500.00)

**IT IS FURTHER RESOLVED**, that when a person to be fined has been previously and expressly warned by the Town, whether verbally or in writing, either not to violate or not to continue to violate a specific Town ordinance, upon a subsequent violation of that ordinance the fines for such municipal infraction violations shall be:

**Fines for Violations of Any Town Ordinance After an Express Warning:**

Any offense: One Thousand dollars (\$1,000.00)

**THIS RESOLUTION**, has been duly posted in accordance with the policy of the Mayor and Town Council of Mountain Lake Park for advertising for the adoption of resolutions, and shall become effective upon the adoption of this Resolution.


**NOW, BE IT FURTHER RESOLVED**, nothing contained in this resolution shall prohibit or prevent the Town from seeking other legal remedies, such as injunction, criminal prosecution, or damages in a civil action pursuant to Section 3 of Article 23A or Section 7.01 of Article 66B, Annotated Code of Maryland as amended.

**THIS RESOLUTION BECOMES EFFECTIVE ON** April 1, 2010.






